Observations

According to the general evaluation and qualification regulations, the preferred evaluation system will be by means of continuous evaluation:

Continuous evaluation will be carried out based on the results of two presencial multiple choice exams related to the course contents. The result of these two surveys will account for 0,5 of the written evaluation tests.

Continuous evaluation of project development will be carried out based on the evidence provided during the evolution of the project. Submission of these evidences will be necessary to access the final evaluation of the project.

The student must obtain at least a score of 50% in the Written Test as well as in the Work Submission and Laboratory Test, in order for the three tests to average for the evaluation. Attendance to the practical sessions is mandatory. Absence must be justified.

Criteria for granting honors:

According to the general regulations, only one honor can be given per every 20 students, not per a fraction of 20, with the exception of the case of groups of less than 20 students in total, in which case one honor will be awarded. In addition, according to the agreement of the Faculty of January 26, 2010:

- Only honors may be awarded on the first or second calls of the student's first year of enrollment in the subject.
- The professor may grant honors only to students who have obtained an outstanding grade in the subject (a 90%-grade or higher). In the event that the final grade of two students is similar, the grade obtained in the final exam will be used as the discriminating criterion and, if these were similar, the results of the Group Works, the Questionaries and the Lab Notebook, in this order, will be considered.

MENTION OF DISTINCTION:

In accordance with the regulations governing the assessment and grading of subjects in force at UCV, the distinction of "Matrícula de Honor" (Honours with Distinction) may be awarded to students who have achieved a grade of 9.0 or higher. The number of "Matrículas de Honor" (Honours with Distinction) may not exceed five percent of the students enrolled in the group for the corresponding academic year, unless the number of enrolled students is fewer than 20, in which case a single "Matrícula de Honor" (Honours with 9 Distinction) may be awarded. Exceptionally, these distinctions may be assigned globally across different groups of the same subject. Nevertheless, the total number of distinctions awarded will be the same as if they were assigned by group, but they may be distributed among all students based on a common criterion, regardless of the group to which they belong. The criteria for awarding "Matrícula de Honor" (Honours with Distinction) will be determined according to the guidelines stipulated by the professor responsible for the course, as detailed in the "Observations" section of the evaluation system in the course guide.
